STARS (Support Team for Abbots Ripton School) is a registered charity and the PTA (Parent Teacher Association) set up to support and raise funds for Abbots Ripton C of E School.

We organise and run fundraising & community-engagement events, to increase opportunities for the pupils and unite the school community.

This year we were involved in over 15 different initiatives. This generated a profit of almost £9000.

Our number one funding project was a donation of £4000 towards the costs of the new IT equipment, including tablets and laptops.

Additional donations from STARS helped towards the costs of books, educational equipment, Easter celebrations, new furniture and storage systems, and subsidising events and trips for the pupils.

CHAIRPERSON'S REPORT 2024/25

Mrs Nixon helped with PTA activities before the STARS name was even adopted, and had an abundance of experience that served us well, helping us avoid many pitfalls along the way, and Mrs Matthews was always the unsung "volunteer" at every STARS event. This of course came with her job role, but there was never an event where it felt like she was there out of obligation, and she would often be at events long after the other volunteers had gone home. So before we review the past year, STARS would like to express our heartfelt thanks to these two outstanding individuals.

In these times of change and transition STARS has sought to be a constant, delivering popular repeat events and not introducing too much additional change to our school community.

It will have been noticeable to some that STARS scaled back the number of initiatives it delivered in the last year, this was intentional for a couple of reasons. We are of course aware that the cost of living plays its part for everyone's budget one way or another, and we didn't want to create additional expectations on people if we could help it. Additionally we have also been operating with a significantly smaller lead team. This has not been by accident as we have sought to refine what we do and our efficiency at delivering quality events. Looking forward we hope to grow a team that continues to steer STARS from strength to strength.

As always all our initiatives were well supported by the generous school community. This generosity does not go unnoticed, and is hugely appreciated by STARS and of course the Staff and pupils at Abbots Ripton C of E School. So a huge thank you to all who have supported the things we do.

Highlights

Some of the highlights of this year's STARS activities include the in-school shops, Christmas events, and of course the Summer Fair. The Summer Fair had a number of refinements based on previous experience, and we were able to increase the income by approx. 10% on the 2024 event - which itself saw an increased income of approx. 10% on the 2023 event. Serving quality food and drink has been key to this success, and this is something we seek to build on moving forward. Our new Christmas event, the Elf Workshop, was initially met with scepticism by a handful of folk, but proved to be a big hit with the children. The whole event was an entirely new concept from the ground up, and with detailed planning led by Emma Wadsworth delivered a memorable experience brimming with Christmas cheer. Another new initiative was the Pancake Flip, which was much more successful than anticipated, raising a considerable amount and creating a lot of fun for the pupils!

Thanks

Special thanks of course go to the core volunteer team of Trustees and Elected Committee Members who have worked to keep the PTA up to standards expected of charities, ensuring we are good stewards of the funds raised. STARS are also very grateful to the wider team of regular volunteers who are always prepared to help make great initiatives a reality, showing up and rolling up their sleeves to get stuck in. In my three years as Chairperson for STARS everyone's efforts have resulted in over £33,000 income generated, the construction of two metal sheds and the cabin classroom, all of which have had a significant impact on the school. An impressive result for all involved!
